The NERIS community is still increasing! After the involvement of the Swedish Radiation Safety Authority (SSM), it is my pleasure to welcome the Belgium Federal Agency of Nuclear Control (FANC) as member of the NERIS association. We hope to welcome other members in the following months in order to enlarge the exchange on emergency and recovery issues and challenges with all the interested stakeholders and organisations.

As you can see in this Newsletter, several European research projects, funded as part of CONCERT EJP, will finish at the end of this year, leading to the organisation of several final workshops this autumn. These projects will contribute to improve the preparedness for emergency response and recovery from nuclear events and the workshops will provide the opportunity to further interact with national and international organisations involved in related issues.

Taking into account the recent and on-going research developments as well as the expectations from national and international organisations for improving emergency and recovery management, there is a need to update the NERIS Strategic Research Agenda (SRA) and the NERIS Roadmap. At the same time, a joint effort is being made with all the European radiation protection research platforms to finalise the Joint Roadmap on radiation protection research issues, which will structure future European research in this field.

Among the challenges for this year, it is worth mentioning the importance of promoting the involvement of young researchers in NERIS activities and reinforcing Education & Training in the field of emergency and recovery preparedness.

Finally, I am pleased to announce and support, on behalf of NERIS, the creation of a new European research platform, SHARE, dedicated to social sciences and humanities. These issues are largely addressed in NERIS activities and will certainly benefit from this new platform, which will organise its first General Assembly on July 4, 2019 in Barcelona.

#### The 10<sup>th</sup> NERIS General Assembly

40 participants from 12 countries attended the Ninth NERIS General Assembly, which was held on April 3rd, 2019 at the occasion of the 5th NERIS Workshop in Dublin. The General Assembly allowed sharing and discussing the annual report, the financial situation, and the review of the on-going activities of the NERIS Platform.

#### The 5th NERIS Workshop -Roskilde, Denmark 3 – 5 April 2019

On 3-5 April 2019 in Roskilde, the NERIS Platform organised its 5th Workshop in cooperation with DTU Nutech. The Workshop gathered 85 participants and 58 papers, including 12 posters, dedicated to "Key challenges in the preparedness for emergency response and recovery of a nuclear or radiological event" and addressed the following challenges:

- Radiological impact assessment during all phases of nuclear and radiological events
- Countermeasures and countermeasure strategies in emergency
   recovery, decision support & disaster informatics
- Setting-up a trans-disciplinary and inclusive framework for preparedness for emergency response and recovery



A specific session was dedicated to "Challenges in estimating the source term and operational radiological picture (on-site versus off-site)".

#### **NERIS Working Group on ICRP recommendations**

NERIS cooperation with the NEA-CRPPH-EGIR on the draft ICRP Publication Application of the Commission's Recommendations for the protection of People and the Environment in the event of a Large Nuclear Accident –Update of the ICRP Publications 109 and 111

At the end of January, the International Commission on Radiological Protection (ICRP) launched a pre-consultation with its "Special Liaison Organisations" (SLO) on the draft publication "Application of the Commission's Recommendations for the Protection of People and the Environment in the Event of a Large Nuclear Accident" – Update of ICRP Publications 109 and 111", developed by the ICRP Task Group no 93. NERIS has cooperated with the Expert Group on the Implications of Recommendations (EGIR) of the Nuclear Energy Agency Committee on Radiological Protection and Public Health (CRPPH), in organising a meeting to jointly discuss and comment the draft. Several members of ICRP (as observers) and NERIS met together with EGIR at the NEA premises in Boulogne-Billancourt, France, on 26 February 2019.

Both EGIR and NERIS have highly appreciated the opportunity to review the draft prior to the public consultation. They acknowledged the usefulness of the document, the integration of recommendations from the different phases into a single document and the enormous effort made by ICRP to produce it. However, a significant amount of comments, of the order of 200 of different relevance, has been compiled and summarized by the CRPPH Secretariat. These comments were referred to the overall scope, the terminology, the definition and use of reference levels, the balance between radiological and non-radiological risks, the social and economic aspects, the stakeholders involvement, the protection of responders in the recovery phase, the international cooperation and transboundary coordination and the lessons from Chernobyl and Fukushima nuclear accidents, among others.

The draft has been updated by the ICRP and there will be an open ICRP consultation process during summer 2019. To gather comments from the NERIS community, a one-day meeting of the NERIS Working Group on ICRP recommendations will take place at CEPN on 26 July 2019.

#### **Activities of the RODOS Users Group**

The yearly meeting of the RODOS Users Groups was held in Bilthoven (The Netherlands), hosted by RIVM, on 6-7 May 2019. More than 50 participants from 17 countries were present.

The meeting focused on:

- Informing all users of the RODOS decision support system about the recent developments of the system,
- Reporting and discussing about the use of RODOS in the RUG member countries,
- Discussing about the priorities for further development of the system.

Furthermore, the meeting participants had the chance to visit the crisis center at RIVM, including an introduction into the use of the RODOS system within the crisis center in case of an emergency.



All presentations shown during the meeting will be distributed within the RODOS User Group electronically within the next weeks.

The announcement for the next RODOS User Group meeting in 2020 will be send out in autumn 2019 at latest.

#### Consultation on the update of the NERIS SRA

As a side meeting of the 5th NERIS workshop, organized at DTU in Roskilde, Denmark a NERIS R&D Committee meeting was organized on the 2nd of April 2019. The meeting was open to all participants of the NERIS workshop already present in Roskilde and was mainly organized as a brainstorming session to explore a potential update of the current Strategic Research Agenda (SRA) of NERIS. In the context of the CONCERT project an updated version of the platforms SRA's is foreseen as deliverable by November 2019.

From the meeting it became clear that a large update, changing key research areas and/or topics, is not required. The SRA was not that long ago largely restructured (the current version can be downloaded from the NERIS website: https://euneris.net/library/sra-1/156-updated-version-of-the-neris-sra.html) and several research projects addressing some of the main challenges of the current SRA are currently on-going. However, during the meeting over 20 ideas were launched and discussed. Some of them included new research themes fitting in one of the key research topics, others mainly reformulate some of the existing research question based on new insights.

All ideas have been integrated in a first draft version of an updated SRA which is currently revised by the NERIS R&D Committee and Management Board. A version for further consultation is expected to be ready before summer holidays. Next steps are:

- A broad consultation process with possible input from all NERIS members, the other radiation protection platforms and international organizations: this is sheduled from 1st of September till 30th September;
- The compilation of a version with the comments from the consultation process to be discussed during Radiation Protection Week in Stockholm during the R&D Committee Meeting (18 October 2019);
- The finalization of the updated SRA and the introduction as CONCERT deliverable (November 2019).
